TERMS OF REFERENCE

1. NAME OF THE COMPETITION

13TH FUTURE OF AUTOMOTIVE DESIGN COMPETITION (13. FADC)

2. ABOUT THE COMPETITION

The “Future of Automotive Design Competition” is a design competition aimed at the automotive industry, organized by “Uludağ Automotive Industry Exporters' Association (OIB)” under the coordination of “Türkiye Exporters' Assembly (TIM)” and with the support of “Republic of Türkiye Ministry of Trade”.

3. OBJECTIVES OF THE COMPETITION

- Establishing an R&D and design culture integrated with technology in Türkiye,
- Accumulating a sufficient knowledge base in R&D and design,
- Enhancing value added in exports,
- Designing component-based innovative products,
- Designing and developing innovative automotive industry oriented software for Türkiye and its region,
- Promoting the cultivation of new designers/entrepreneurs,
- Having Turkish exporters develop unique products for global markets,
- Presenting innovative and/or unique projects in the automotive industry and bringing such projects together with leaders of the industry, students, academics, investors and entrepreneurs.

4. TERMS OF APPLICATION TO THE CONTEST

- The contest is open for the participation of all industry professionals, academics, R&D personnel, technopole workers, designers, entrepreneurs, freelancers and students interested in the industry. All persons over the age of 18 can participate in the contest individually or as a team. In team applications, one person should be identified as the team leader.
- For applying projects, conditions sought are: (i) being innovative within the automotive industry of Türkiye and/or its region; (ii) not being mass produced. In case otherwise is determined, the project shall be disqualified from the competition, and the prize (if awarded) shall be recollected fully in cash by OIB. The competitor who is awarded guarantees to return the prize and the amount received if such circumstance occurs. Moreover, in cases where the project submitted to the competition is found to not be a unique and original piece of work, where a claim to such effect is asserted and where third parties make a claim to the design, the responsibility rests with the competitor.
- There is no limitation on the number of projects to be applied for in the competition. A single competitor may apply with several automotive industry related projects, provided that each project is different. However, within the same competition year, only 1 of such projects may be awarded.
- In team applications, one person should be identified as the team leader/project executive to pursue relations with OIB. Each team member is jointly and severally responsible before OIB. If the applying team member(s) have not received education from any educational establishment, no graduation certificate, diploma or student certificate will be sought, on the condition that a written statement to such effect is presented by the relevant member(s).
- **Pursuant to TIM's instructions dated 12.03.2024 and numbered 24-689; it has been**

decided that the competitor who has received a monetary prize from any design competition organized by our Exporters' Associations shall not participate in other design competitions in the same year.

5. COMPETITION THEME AND SCOPE

Competition Theme: Urban Mobility

The competition focuses on solutions that will shape the future of urban mobility within the scope of projects which will make a difference at the country-region level in general design, software design and automotive industry, in line with the transformation in automotive industry. The term 'general design' covers matters ranging from holistic, visual vehicle design to the design of systems consisting of vehicles and devices which can communicate with each other, the design of automotive industry components (parts and accessories) and the technical design of infrastructures such as charging and batteries. The term 'software design' signifies the software design generating innovative solutions for mobility issues such as vehicle sharing; connected, autonomous, electric and other alternative fuel vehicles, location-based applications, smart parking applications, smart networks and smart infrastructure applications, digitalization and so forth. In addition, all projects that include the following themes will be evaluated within the scope of the competition: intelligent transportation systems that can contribute to urban mobility (traffic management platforms, mobility applications, parking lot management, etc.), autonomous vehicles, connectivity of vehicles and smart devices with other vehicles and devices, remote updating of vehicle softwares, sharing economy, vehicle sharing, technologies that reduce congestion and increase efficiency, integrated transportation systems, data analytics and artificial intelligence in transportation, blockchain technology, mapping and monitoring infrastructure, 5G, cyber security measures, wearable technologies, renewable and sustainable energy and environmentalist approaches, ergonomics, safety, energy, etc. However, for 2024, efforts will be made to prioritize projects that include solutions for the **URBAN MOBILITY**. Urban mobility solutions include smart traffic management, road safety, transportation infrastructure and sustainable transportation technologies, urban logistics, technologies to reduce carbon emissions, electric vehicles, driving experience technologies, solutions that reduce environmental impacts and improve the overall quality of life in cities.

6. APPLICATION STAGES FOR THE COMPETITION

Application to the competition consists of two stages with the first stage being a declaration-based round of online verification and confirmation of the documents specified here below. At the second stage, the submission of the documents in question will be requested from the finalist project owners for signature and delivery to the Competition Secretariat.

It is obligatory for the following documents which are to be requested during said application stages to be declared and submitted in full and in the requested manner and on the relevant date by the project owner and his/her team to the Competition Secretariat. Otherwise, the applications will not be taken into consideration.

6.1. Online Application and Registration:

Applicants to the competition must fill the online contest application form which is available on the website **www.otomotivingelecegi.com** . Those who fail to make an online application by the application deadline specified on the aforementioned website will not be admitted to the competition. Any responsibility pertaining to deficiencies in the uploaded files rests with the project executive. OIB may not be held responsible for any service disruption. During the online application stage, the project executive is required to accept the Terms of Reference and the PDPL document over the online

application platform.

Due care should be given to abide by the word count limitations specified under the application form and ensure the intelligibility of the text. Project abstracts provided as part of the application form will be printed in a book to be handed out on the day of the event.

During the application, project owners must enter into the system the information requested in full. Any application containing incomplete information will not be taken into consideration.

The projects should not in any way whatsoever display any Personal/Corporate information not belonging to the project owner itself and any Trademark, Logo etc. If a circumstance to the contrary is detected, such projects will be left out of the evaluation.

During project applications, the user will be solely responsible to keep user and project proposal records up to date. In circumstances which may arise out of incomplete or inconsistent registration information, the responsibility rests with the user.

6.2. Pre-Selection:

Online applications will be screened by the pre-selection jury first on paper, then in a face-to-face setting and afterwards in line with the declarations of the lead project officer as to the fulfilment of the conditions set under the competition terms of reference and thereby evaluated. **A maximum of 30 projects** which are found to be eligible to proceed to the next stage will be determined. Selected projects will qualify to be invited before the prize jury to deliver a project presentation.

6.3. Final Selection:

A maximum of 30 projects which pass the pre-selection phase will deliver a project presentation before the prize jury, whereupon **the top 10 projects** deemed to be successful will be determined. Each of the **10 projects** will become eligible to deliver a presentation at the FADC Award Ceremony. The projects in question will be announced on the competition website. The **top 5 projects** which are found to be eligible for the prize will be announced at the Award Ceremony.

The executives of the **10 selected projects** which are found eligible for consideration by the prize jury are obliged to upload to the system the following documents in the requested manner and with the relevant signatures affixed. It is obligatory that said documents are printed out, **signed in wet ink and handwriting on the bottom of each page** and scanned and uploaded in PDF format, with the original copies being submitted within the duration to be specified. **In the case of missing documents, the application will be considered to be invalid.**

Said documents must be drawn up and signed off in line with the definitions provided here below.

Lead Project Officer: A member of the founding team and the responsible person for the application process. Communication will be facilitated through this person throughout the competition process. **(Has a Signatory Obligation)**

Project Officer: This defines the founding/non-founding partners of the project and other beneficiaries. **(Has a Signatory Obligation)**

Project Support Personnel: Person(s) who are not direct beneficiaries which support the development of the project in areas such as marketing, software development, sales, consultancy, finance etc. in accordance with their competences,

1. Competition Terms of Reference

- This document is to be printed out, signed on the bottom of each page and scanned

- In the case of team applications, the lead project officer and each project officer (other partners), if any, will sign the bottom of each page of the same Terms of Reference, which is then to be scanned and uploaded in PDF format. The document will not be accepted in case of missing signatures.
2. **Annex1.Photo & Wet Signature Affixed Design Competition Undertaking/Application Form (Annexed to the Terms of Reference)**
- This document is to be printed out, signed on the bottom of each page and scanned and uploaded in PDF format.
 - In the case of team applications, the lead project officer and each project officer (other partners), if any, will sign the bottom of each page of the same Terms of Reference, which is then to be scanned and uploaded in PDF format. The document will not be accepted in case of missing signatures.
3. **Annex2. Wet Signature Affixed Clarification/Information Form on the Personal Data Protection Law No. 6698 (Annexed to the Terms of Reference)**
- This document is to be printed out, signed on the bottom of each page and scanned and uploaded in PDF format.
 - In the case of team applications, the lead project officer and each project officer (other partners) will sign the bottom of each page of the same Terms of Reference, which is then to be scanned and uploaded in PDF format. The document will not be accepted in case of missing signatures.
4. **Annex3.Deed of Consent: This serves as a petition including a statement on the request for the deposit of the relevant prize amount to the account of one of the team members if the project qualifies for a prize. (Annexed to the Terms of Reference)**
- The document is to be scanned and uploaded in PDF format.
 - In the case of team applications, the lead project officer and each project officer (other partners) will sign the bottom of each page of the same Terms of Reference, which is then to be scanned and uploaded in PDF format. The document will not be accepted in case of missing signatures.
5. **Recent, wet signature and stamp affixed Diploma or, if the relevant person is still a student, Student Certificate received from the school most recently attended***
- A document displaying an official barcode to be drawn up over the e-Government Portal (e-Devlet) testifying to the graduation/studentship will also be accepted.
 - In the case of team applications, it is obligatory to submit separate documents for the lead project officer and each project officer (other partners).
- * If the project support personnel have not received education from any educational establishment, written statement will be taken as basis with no graduation diploma or student certificate being sought.
6. **CV**
- The document is to be scanned and uploaded in PDF format.
 - In the case of team applications, it is obligatory to submit separate documents for the lead project officer and each project officer (other partners).
 - Turkish ID No, Phone No, Address, Name of University/Faculty/Department and Profession must be specified under the CVs for each of the team members.
7. **Copy of Identity Card**

- The document is to be scanned and uploaded in PDF format.
- In the case of team applications, it is obligatory to submit separate documents for the lead project officer and each project officer (other partners).

The 10 finalists which qualify to appear before the prize jury are obliged to submit by cargo or by hand all documents specified under Clauses 6.1 and 6.3 (the wet signature affixed original copies of all documents uploaded to the system, filled in handwriting) to the Competition Secretariat prior to the Prize Jury Meeting.

In the event that the lead officer and his/her team fail to deliver the original copies of the aforementioned documents to the Competition Secretariat within the requested duration, no payment pertaining to the prize will be made if the project qualifies for a prize.

7. COMPETITION EVALUATION PRINCIPLES

For scoring criteria, the Prize Jury Evaluation Form provided here below will be taken into consideration.

8. INSTRUCTIONS

- The competition is free to apply and participate.
- Members of Uludağ Exporters' Association, Uludağ Exporters' Association, Uludağ Automotive Industry Exporters' Association and its employees and Jury Members shall not bear any responsibilities in cases where legal issues arise from the authenticity of the competing projects. All the responsibility shall pertain to the competitor/group.
- Parties mentioned on the article above, shall not be held liable where damages and losses inflict due to agreements or face to face meetings, made or to be made, between the participant and a third person within the context of the competition.
- OIB may cancel the competition in any stage, in such cases the competitors shall not claim any rights. The above-mentioned parties shall have no responsibilities in cases where the competition is cancelled.
- Participants accept and undertake that their names, images, projects, and other information may be used, exhibited, and published indefinitely by OIB for promotional and news purposes.
- The application documents of first 5 ranked projects shall be kept in the Competition Secretariat archive and the competitors acknowledge that OIB has the right to use the mentioned projects for promotional and exhibitivie purposes.
- Either any caveats, allegations, questions to be directed or judicial processes, cases and legal proceedings regarding the projects in the competition, to be initiated by third persons / and /

either team members, due to intellectual property rights, against OIB / Uludağ Exporters' Association / Jury / Organizers shall be jointly and severally undertaken by the person and/or team who has applied for this competition. OIB, the organizer of the competition, / Uludağ Exporters' Association and / or Jury / Organizer shall have no liability in this regard. Related questions, allegations, judicial processes etc. shall be directed to the applicant person and / or group. In this respect, any arising / potentially arising damages and losses caused by the requests of third persons from OIB / Uludağ Exporters' Association and / or Jury / Organizers, shall be jointly and severally indemnified by the person and / or team that has applied to the relevant competition.

- The jury may reduce the number of projects to be awarded in cases where five projects are not deemed worthy of a prize. Projects that are deemed successful shall be declared during the award ceremony and the payments shall be deposited to the accounts of project owners, who have submitted their documents in full, within 2 months following the award ceremony. Competitors, awarded or not, shall not request any other prize or payment other than the mentioned ones for their projects.
- OIB, reserves the right to change the dates of pre qualifiers, main eliminations and award ceremony.
- Previously submitted projects, during the prior competition events organized by OIB, shall not be evaluated unless their deficiencies are redressed and resubmitted.
- In cases where jury detects any violation of Intellectual Property Rights by a project, the project shall not be evaluated. In cases where it is revealed that the design or other elements of the project, that must be unique, have been copied, the prize will not be given, and if it has already been given, the winner shall immediately return the prize. The legal sanction of any problems that may arise, as well as the financial sanction of the processes, shall be the responsibility of the competitor, and OIB / Uludağ Exporters' Association / Jury and Organizer shall not be held liable for any problems that may arise. In such cases, the prize of the competition shall be canceled and the prize shall be withdrawn.
- The competitors are deemed to have accepted and complied with all the conditions of participation set out in this specification.

9. PARTICIPATION EXPENSES

The expenses of the top ten finalists who will appear before the jury on stage at the award ceremony, on the designated day, shall be reimbursed, provided that the expenses are documented by the lead project officer who has passed the pre-selection and qualified to participate in the Jury Evaluation meeting. Submitting the original copies of the aforesaid documents to the Competition Secretariat within the framework of below-mentioned conditions, is compulsory in order for the payments to be made.

- Neither transportation nor accommodation expenses of project owners, participating from the province where the competition will be held, shall not be paid.
- **Participation expenses regarding transportation and accommodation shall be covered by OIB on the condition that they are documented by only one person from the group.** Within the scope of transportation expenses domestic and economy class tickets for flights and intercity transportations through buses, trains and ships shall be covered, however taxi fares, personal vehicle fuel costs and urban transportation are excluded and shall not be covered. Expenses, invoices of which are not submitted, shall not be paid. The questionnaire forms given to the project proposers whose projects are exhibited on the day of the event must be filled in and in order to pay the intercity travel costs of the participants, the original transportation documents of participants coming from outside the province where the event is held must be submitted to the event agency, accompanied by a wet-ink signed petition including bank information.

Following the submissions of invoices the event agency shall transfer the payments to the bank accounts.

- The expenses of competitors who fail to submit the original invoices to the Competition Secretariat shall not be covered and competitors are required to upload their identity card image to the system in order for payments to be made.
- The accommodation requests of our guests coming from outside the province, where the event is held, shall be specified in the Application Form to be submitted. Accommodation shall be determined by OIB in line with the budget and availability. Potential objections, coming from guests, regarding the accommodation shall not be taken into consideration.

10. PRIZES

The ranking of projects deemed to be successful under the above specified application terms and conditions for the Future of Automotive Design Competition will be announced at the prize ceremony and prize payments will be made through wire transfer to the account of the relevant competing project owners within 2 (two) months from the prize ceremony, with circumstances specified under the present Terms of Reference and the case of the cancellation of the prize for any reason whatsoever remaining reserved.

In cases where taxes arise regarding the prize pursuant to the laws of Republic of Türkiye, the tax expenditures shall pertain to the competitor. When deemed necessary for the efficacy of the competition, OIB has the right to change the number of winners according to the quality and amount of presentations. In the event that the projects are not deemed worthy of an award, it may, if it wishes, allocate the vacant rank in a category among the ranks in the same or different categories or leave any or all of the award levels blank.

11. SCHOLARSHIP FOR STUDYING ABROAD ON DESIGN

A total of **3 persons comprising of 1 person each from the top 3 projects which qualify for a prize**, whom will be selected from among those **lead project officers or project officers (other partners), if any, which meet the condition of having graduated with a bachelor's degree from the industrial design/fashion design related departments of universities** (in the case of group participations, 1 person specified under Annex-3 Deed of Consent who meets the application terms and conditions) may apply for a Foreign Education Scholarship within the scope of Articles 5 and 6 of the Circular on Design Organization Support Pertaining to Export Subsidies Decision No. 5973, which refer to Support to be Provided for Foreign Education and Living Expenses.

Article 5:

(1) Designers shall benefit from the support for studying abroad and living expenses within the scope of this Circular for one time only.

(2) **Life and education expenses of designers graduated with a bachelor's degree from departments related to industrial design/fashion design of universities are supported within the scope of this Circular.**

(3) The designers, determined by the Ministry, shall commence their educations on the semester that

is designated in the application.

(4) The designer, who went abroad for education, shall submit the certificate, diploma, etc. showing that the foreign education has been completed, to the relevant business association within 3 months at the latest following the completion of the training program. Business Association delivers the mentioned documents to the Ministry.

(5) Support payment regarding studying abroad and life expenses shall only be made to the Business Association within the scope of this Circular. The support payment shall only be made after the expenses are invoice in the name of the designer and the payment shall be made by the relevant business association.

Article 7:

(1) After conducting the supported organizations within the scope of this Circular, the highest ranked 3 designers (a designer for each rank determined by the business association) who request to apply for studying abroad shall apply to the internationally known education institutions on design, determined on Annex-4, through the Ministry of Trade. Designers apply to the business association organizing the design competition together with the documents, listed in Annex 3 by the Ministry of Trade, following their acceptance from the educational institutions they apply for

their education abroad. In order to conduct the conclusive inspections and determine the designers to provide education support, relevant business association submits the applications of designers together with the documents mentioned in Annex 3 through Electronic Document Management System (DYS) to the Ministry in April of each year provided that it is within 2 calendar years following the the year of competition.

(2) Pursuant to Annex 5, the Ministry determines designers, who will be provided with both education and life expense support, through the results deriving from the considerations based on the education institution where the designer is accepted, competence of foreign language and the ranking in the competition, thereafter mentioned designers are declared to business associations via DYS.

(3) In order to be included within the scope of support it is essential for a designer to have at least 60 points from either The Foreign Language Knowledge Level Determination Exam (YDS) / e-YDS or a foreign language exam result document proving a score of at least 60 points and above in YDS/e-YDS according to the calculation made on the basis of Measuring Selection and Placement Center (ÖSYM) International Foreign Language Exams Equivalencies Document. Foreign language certificates must have been obtained within 3 years retrospectively as of the end of April of the relevant year in which the application for inclusion in the scope of support for overseas education and living expenses is made.

(4) Following the approval of the Ministry regarding the determination of the designers to be sent for training abroad, the relevant business association shall complete the necessary procedures related to the design school which accepted the application.

(5) After the evaluation made by the Ministry, a contract shall be concluded between the designer to be sent abroad for training and the relevant business association regarding the training to be received abroad and mutual obligations. Issues below have to be included in the contract in question regarding designer receiving educational support;

a) After successfully completing his/her education abroad; shall provide training and consultancy services on fashion, trend and industrial design for 1 year, if requested by the relevant business association,

b) Shall not change the training program without the permission of the relevant business association,

c) Shall not voluntarily leave the school where he/she is studying for a reason not accepted by the Ministry,

ç) In cases where he/she does not complete the training program within 1 year at the latest without a valid excuse, he/she shall undertake to repay the supports provided under this Circular within the framework of the provisions of the Law No. 6183 on the Procedure for Collection of Public Receivables dated 21/7/1953,

d) The commitments given under subparagraph (ç) shall be accompanied by a personal guarantor or other collateral and other issues deemed appropriate to be added by the business associations.

- For the design scholarship given by the Ministry of Trade for design scholarships in foreign

schools, information shall be provided separately for the applications of the ranked designers after the end of the competition (after the announcement of the ranks at the award ceremony), and all documents to be requested together with the documents mentioned in Article 7 shall be sent to the Republic of Turkey Ministry of Trade within the framework of this Circular.

- The project owner, who is deemed appropriate by the Ministry of Trade, can be sent for education in internationally recognized education centers abroad for **a maximum period of one year**, and the training expenses and living expenses related to this period shall be covered within the framework of the mentioned Circular,
- The conditions for applying for this scholarship will be communicated by OIB via e-mail within two (2) months after the award ceremony,
- Provided that the matters specified in its content are adhered to, the application process starts after the notification e-mail is received.
- The requested documents must be submitted to OIB in full, in the requested form and with wet-ink signature as original documents by the requested date,
- Applications with lacking documentation and after the declared date shall lose the right to apply,
- Being eligible to apply and submitting the documents does not guarantee a scholarship,
- The final decision-making authority regarding the aforementioned scholarship is the Ministry of Trade,
- The designers to be selected must meet the student admission requirements required by internationally recognized education centers abroad,
- The condition of being a Turkish citizen is required,
- OIB has the right to request presentations, reports, etc. from the project owners who will benefit from the scholarship on topics, events and activities, etc. to be determined by OIB. Upon this terms of reference, the recipient of the scholarship shall be considered to have accepted this.
- In the case of team applications, the project manager and team members will be requested to provide information on issues such as their responsibilities within the scope of the qualifying project and whether they are designers or not.

12. COMPETITION SCHEDULE

OIB reserves and shall have the right to alter the dates set forth in the competition schedule. In the event that an alteration occurs in the competition schedule, it shall be announced on the event web site and social media pages.

13. JURYMEN

Jury members shall be determined by OIB. OIB reserves the right to change the jury list in case of a force majeure. The aforementioned change shall be announced on the website. Decisions made by the jury are definitive and cannot be challenged. The participants shall be regarded as having agreed to this term. By participating in the competition, the competitors declare that they shall respect the decisions of the Jury.

Employees of the Association, members (even if resigned) and relatives up to the third degree of the jury and persons who work at the same institution as a jury member cannot participate in the

competition. In case otherwise is determined, the project is disqualified from the competition, and the prize (if awarded) is recollected fully in cash by OIB.

14. INTELLECTUAL AND INDUSTRIAL PROPERTY RIGHTS AND DISPUTE RESOLUTION

- Design submissions breaching intellectual property rights shall be disqualified. All legal actions of third parties shall be under the responsibility of the competitor.
